- ❖ You will be informed of Written Exam results by AAAM by **11 October noon**

### Part 2: Oral Examination – 11 October 2010

**1300 hrs onwards**

- ❖ Candidate will have to meet with 1 Board Examiner (15 mins per candidate)
- ❖ Candidate will be notified of Oral Exam time schedule nearer to date
